

Petrichor Broadband, LLC - Notice of Special Meetings Open Public Meetings Act- Special Meetings

The Washington Open Public Meetings Act (OPMA), codified in chapter 42.30 RCW, requires that all meetings of governing bodies of public agencies be open to the public. A "meeting" under the OPMA occurs when a quorum of the governing body gathers with the collective intent of transacting the governing body's business. When four or more Executive Council members attend a meeting or event, a quorum is present, and therefore there is potential for inadvertent "action". "Action" is broadly defined under the OPMA so that any time a quorum discusses, in any way, Petrichor business or issues, it is considered "action" under the OPMA. It is the intent of the Executive Council of Petrichor Broadband, LLC to not transact Petrichor business at meetings or events offered by other organizations.

Under the OPMA, the required notice for Special Meetings shall specify the time and place of the special meeting and the business to be transacted. Final disposition shall not be taken on any other matter at such meetings by the governing body.

A quorum of the Executive Council may be present at the meetings and events listed below. Members of the public that are interested in attending the meetings should contact the meeting sponsor. This notice will be updated as information becomes available.
